 - International RT on financial access co-convened by World Bank, Dutch MinFin and HSC
 - Dutch RT on financial acces co-convened by HSC MinFin in partnership with MOFA and Dutch Banking Association

Working in partnership with FATF supports NPOs in sensitive and critical contexts

Opening up of engagement between NPOs and governments, other stakeholders

Explore ways together with the FATF Secretariat of addressing the misuse/abuse of FATF Standards - a shared concern

Very helpful recent statement of FATF Prez – abuse of AML/CFT standards to oppress Human Rights under pretext of CT in contravention of risk based approach. Country will be assessed negatively for not implementing a risk based approach

Serbia case on power of local NPOs in their understanding of FATF AML/CFT standards and recommendations, the mechanisms of UN SRs and readiness of FATF to remedy NPO abuse.

2013 – 2021 From awareness raising to understanding to consultation to dialogue to concrete action

Trust building through sustained engagement

- Trusted conveners of Global NPO Coalition and Round Tables
- Single point of contact at the FATF
- Transparency and Accountability of the Global NPO Coalition

Combined approach: awareness raising, outreach/capacity building, research, dialogue, advocacy leading to actions

Communication through various outlets about practices, solutions/achievements, challenges Support of donors for resources – long-term commitment requires long-term investments Support of governments: MoFA: Development, Security, Humanitarian, MinFin, MinJustice, FIUs, bank regulators

Role of the FATF president vital for gaining traction for advocacy objectives

Challenges

Transparency of CFT and broader CT decision-making that impacts NPOs

Implementation of CFT at the national level

Policy incoherence – CFT and CT measures continue to undermine humanitarian aid, human rights, SDGs, civic and civil society space

- Financial exclusion
- CFT Donor clauses resulting in the downstreaming of risk to NPOs at frontlines of conflicts and crises
 - Beneficiary vetting
- CFT and CT measures counter- productive if civic and civil society space restricted

Alignment of UN SCR 2462 and the FATF standards

Multi-stakeholder dialogue on broader CTM impact on civic space at international and regional levels
